### **What is a Virtual Horse Show?**

**A horse show that is created by videos! The exhibitor submits a video for a specific class demonstrating the requirements. The video is reviewed by a judge with scoring and feedback.**

**The results will be posted and ribbons and prizes mailed. No need to haul to the show! The show is wherever you are!**

**Classes #1 through #14 will be judged on April 15<sup>th</sup>.**

**Classes #15 through #31 will be judged on April 22<sup>nd</sup>.**

**Classes #32 through #40 will be judged on April 29<sup>th</sup>.**

**But any and all classes can be submitted before their judging date.**

### **How do I participate?**

**Create a video. Really all you need is your cell phone. No editing, no music, horizontal frame. Then submit it with your entry form and release. Payment can be mailed to address provided. Once payment is received your video will be reviewed and scored. After all videos have been scored - ribbons and prizes will be mailed to you.**

### **What do I wear?**

**Proper riding attire is suggested but not mandatory. However, you should look tidy. Helmets required under 18.**

### **Does my horse need to be clean?**

**Your horse should be clean. Not necessarily “show clean” but look the part. Fuzzy horses are ok!**

**Can I enter more than one class?**

**Yes! You must submit an entry form with classes along with your videos!**

**Where do I find the patterns?**

**They are posted in the Facebook event.**

**What if I don't live in Texas, can I still participate?**

**Yes. We will take videos with the proper entry form and payment from anywhere in the World.**

**What are the prizes?**

**They are currently being planned! But they will be easily mailed. And will include a ribbon - 1st to 6th place. Remember – this is about HAVING FUN and continuing to work on yourself and your horse.**

**Can I show 2 horses in the same class?**

**Yes. Submit 2 videos and 2 entry forms!**

**Where do I submit the videos?**

**Videos or a Video Link may be emailed but must contain name and class number. Each class entry must have its own video. Email to [chapsride@gmail.com](mailto:chapsride@gmail.com).**

# **RULES AND DIVISIONS**

This is a FUN SHOW!!!!

Please use common sense and safety guidelines.

No excessive riding or training techniques..... Whipping, spurring, etc.

Judges opinion is final.

Judge reserves the right to combine and/or split classes as deemed necessary.

All submissions will receive placing and feedback.

This is a FUN SHOW..... let's all come together and enjoy this quarantine time with our horses.

All class entries, if not designated in the actual class name, will be judged in Youth (under 18 as of 1/1/2020) or Open.

This Release Agreement (the "Agreement") is made this \_\_\_\_ day of \_\_\_\_\_, 2020, by \_\_\_\_\_, whose address is \_\_\_\_\_ (herein, the "Releasor").

WHEREAS, the Releasor desires to ride horses and/or engage in horse related activity as in conjunction with an event (an "Event") sponsored by Rockin RJ Ranch and it's associates, and  
WHEREAS, in order to participate in an Event, Rockin RJ Ranch requires each participant to execute this Agreement.  
THEREFORE, in consideration of participation in an Event, Releasor agrees as follows:

1. Acknowledgement. Releasor (and Parent Releasor, if applicable) acknowledges that horseback riding and/or horse related activity is a dangerous activity, and as a participant, Releasor and/or any and all horse(s) utilized by Releasor during the course of Releasor's use of participation in an Event may suffer serious physical injury or death, or may cause injury or death to another's property or person, or to the property of Releasor, and that all risks connected with the use of a horse or participation in horse related activity and/ or riding in an Event are to be borne and assumed by Releasor.

2. Release and Indemnification. Releasor (and Parent Releasor (defined below), if applicable), for himself/ herself, his/her spouse and/or minor children, legal representatives, successors, heirs and assigns, hereby releases, holds harmless, waives and discharges Rockin RJ Ranch and, its officers, directors, incorporators, representatives, agents, employees and volunteers (herein, collectively the "Releasees") from any and all liability for any and all loss or damages of any nature whatsoever, and any claim or damages resulting therefrom whether directly or indirectly, on account of injury to Releasor's person or property including but not limited to injury and/or death resulting to Releasor's horse(s) whether owned, leased, borrowed, and/or utilized by Releasor, including injury resulting in death of the Releasor, arising out of or relating to Releasor's participation in an Rockin RJ Ranch Event, whether caused by the negligence of Releasees, a third party, or otherwise.  
Releasor (and Parent Releasor, as applicable) agrees to indemnify the Releasees and each of them from any loss, liability, damage or cost, including any and/all costs and attorney fees that Releasees may incur due to the Releasor's participation in an Event.

3. Authority. Releasor represents that he/she is at least eighteen (18) years of age, is not under a disability, and has full capacity to execute this Agreement. In the event Releasor is a minor child, a parent or legal guardian shall also execute this Agreement on behalf of said minor child as "Parent Releasor".

4. Consent to Photograph. Releasor (and Parent Releasor, if applicable) give permission to Rockin RJ Ranch, and/or to parties designated by Rockin RJ Ranch, to photograph Releasor and to use any such photographs/videos in all forms of media, and for any and all promotional purposes including advertising, display, audiovisual, exhibit or editorial use. Releasor (and Parent Releasor, if applicable) further consent to the use of Releasor's name in connection with any such photographs. Releasor (and Parent Releasor, if applicable) acknowledge and understand there will be no financial compensation for the use of any such photographs/videos or use of Releasor's name, and hereby release Rockin RJ Ranch from any and all claims related to the use of such photographs/videos for the purposes stated herein.

5. Governing Law. This Agreement shall be governed and construed in accordance with the laws of the State of Texas..

**Releasor and Parent Releasor, as applicable, acknowledge(s) that he/she has read this Agreement and fully understands its contents. Releasor and Parent Releasor, if applicable, understand(s) that this Agreement is a release of liability and acknowledges that she or he can read the English language and is entering into this Agreement of his/her own free will.**
